Vendor Hold Harmless / Insurance Agreement 2009

The Vendor agrees to maintain in full force a policy of comprehensive general liability insurance under which the Township of Ocean recreation Department, doing business as the Township of Ocean is named as additionally insured and under which the insurer agrees to indemnify and hold the Township of Ocean and the Recreation Department harmless from and against all costs, expense., including reasonable attorney's fees, and/or liability arising out of or based upon any and all claims, accidents, injuries and damages arising out of the Vendor's operation at the above mentioned event (s).

The vendor also agrees to indemnify and save harmless the Township of Ocean and the Recreation Department from all claims of whatever nature arising from, or claimed to have arisen from, any action, omission, or negligence of the Vendor, or arising from any accident, injury or damage whatsoever caused to any person or property arising out of the Vendor's operation at the following listed events. The Vendor agrees to name the Township of Ocean and the Recreation Department as additionally insured, and provide a valid certificate of insurance with a liability limit of at least \$500,000 per occurrence.
